Thank you for your request to the Welsh Government for information received on 11 October which will be dealt with under the Freedom of Information Act (2000) (FOIA). You have requested the following:

• To provide a list of 'red list' drugs? Drugs which are approved but are restricted because of their cost

Response

Welsh Government does not hold the information you have requested and there is no national 'red list'.

We have assumed that your request relates to medicines which are designated as "less suitable for prescribing" or "not for prescribing" in health board medicines formularies where traffic light categories are often used.

Medicines which cannot be prescribed by general practitioners in Wales can be found in Part XVIIIA of the England and Wales Drug Tariff *Drugs, Medicines and other Substances not to be ordered under a General Medical Services contract* available at Tariff.book (nhsbsa.nhs.uk)

Medicines not recommended for routine use in NHS Wales on the grounds their cost effectiveness has not been demonstrated can be found by reviewing individual appraisal recommendations published by the National Institute for Health and Care Excellence at Published guidance, NICE advice and quality standards | Guidance | NICE and the All Wales Medicines Strategy Group at Medicine recommendations - All Wales Therapeutics and Toxicology Centre (nhs.wales)

Next Steps

The request you sent me contains personal information about you - for example, your name and address.
