ATISN 17055 – Waiting Times

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 16 January 2023. You have requested the following:

Data broken down by calendar month and by local health board for December 2018 to December 2022 on:

- the number of times a patient on a Referral to Treatment Waiting Times (RTT) in NHS Wales pathway was admitted as an emergency and treated for the condition their RTT pathway related to during their emergency stay, therefore ending the RTT pathway.
- how many times an RTT pathway ended due to a patient's death.

Response

The Welsh Government does not hold the information you have requested. Instead, it may be possible to obtain this information from individual health boards. I have attached a link to the contact details for each of the health boards as follows:

Next Steps

The request you sent me contains personal information about you - for example, your name and address. - to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
