- b) WG are required to publish all expenditure over £25k, I note this is being published on a monthly basis; Welsh Government expenditure over £25,000 | GOV.WALES
- c) How can we understand total spend per annum per contract e.g. How much Welsh Fisheries are spending with Hugh James.

## 2) VMS Succorfish Contract

- a) When WG entered into a contract with Succorfish.
- b) The procurement route undertaken to enter into this contract (which year) and for initial contract term.
- c) During the tender process, what evaluation was applied with Quality & Price.
- d) Number of tenders received.
