## Response

Following a search of our records, Welsh Government does not hold information which falls into scope of your request and can confirm that no internal reviews have been undertaken.

Welsh Government is advised by experts at Public Health Wales and UK Health Security Agency on matters of public health concern which includes incinerator emissions and health effects.

Public Health Wales published their <u>view</u> on incinerator emissions and health effects in January 2020 and is committed to work with other UK public health agencies to keep the position under review.

## **Next Steps**

The request you sent me contains personal information about you - for example, your name and address.
