ATISN 18588 – Ketamine Use

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 12 June 2023 relating to Ketamine use. You requested the following:

- a) *Please share any data you have around ketamine use in Wales*
- b) *You are particularly interested in understanding the health implications this drug use might be having on people, and*
- c) *To see any Police data surrounding arrests or cautions because of Ketamine and whether there's an increase or decrease this year compared to the last few.*

Response

- a. Welsh Government does not specifically hold data relating to Ketamine, however information on treatment data is publicly available but it doesn't specifically highlight Ketamine as a drug. <https://www.gov.wales/sites/default/files/publications/2022-05/treatment-data-substance-misuse-in-wales.pdf>

- c. Welsh Government does not hold information relating to arrests or cautions due to Ketamine use. As policing is not devolved, you may wish to contact the Home Office for data relating to this.

Next Steps

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability

- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
