## Request for Information – ATISN 18756

I wrote to you on 24 July regarding your request for information.

## **Your Request**

You asked for:

- 1. Telephone and email contact of WGC Holdco Limited who are the company running at arms length the Cardiff airport operation.
- 2. What company is offering the shares to buy shares in Cardiff International Airport Itd
- 3. Why does this company not have any contact details in the public domain or even at the Welsh office customer help desk?

### Our response

The Welsh Government, on behalf of the Welsh Ministers, operates Cardiff International Airport Ltd as an arms-length private limited company, with distinct separation achieved through WGC HoldCo Limited (HoldCo). HoldCo was incorporated as a private company limited by shares on 21 March 2013.

HoldCo acquired Cardiff Airport on 27 March 2013. The objective of the acquisition was to secure the airport's future, enable the commercial management team to reinvigorate activity levels, and ensure its continued contribution as an asset to the economy and people of Wales. HoldCo owns 100 per cent of the ordinary share capital of Cardiff Airport. As such, whilst the airport is a wholly owned subsidiary of the Welsh Government, it operates in an independent and commercial manner, makes investment decisions on a commercial basis, and is liable for its own actions and any issues arising from the running of its business.
