Request for Information – ATISN 20024

Thank you for your request for information dated 18 December.

Information requested

Relating to the Traffic Orders and 20mph Public Attitudes Survey -

1. Were all 1002 adults interviewed **online** from Wales? Or did some live outside Wales? Were all 1002 people from across Wales? Can this be proved?
2. What was the percentage of drivers v non drivers interviewed?
3. What was the percentage of people asked e.g. 18-30, 31- 40, 41-50, 51-60, 61-70, 71-80, 81+?
4. Is there any representation in the report from people under 18? The reports states 1002 adults. Adults are classed as 18+.
5. What was the percentage of people from each Welsh County please? This is important as people living in a city like Cardiff would have different views compared to rural Ceredigion etc.

Our response

1. All were Welsh residents, based on dual check consisting of postcode information provided at point of registration and a survey check question establishing in which local authority they live.
2. 75% of those interviewed were drivers.
3. Data was weighted by age group, gender, Local Authority grouping and social grade to match Census figures and ensure it is representative of the adult population (16+) in Wales. The unweighted and weighted age profile of the interviewed sample was as set out below.

4. For the purposes of survey research adults are defined as being age 16+. 20 of the 1002 respondents were age 16/17.
5. Data was weighted by age group, gender, Local Authority grouping and social grade to match Census figures and ensure it is representative of the adult population (16+) in Wales. The unweighted and weighted profile of the interviewed sample was as set out below.
