NB. This is a live issue and therefore a further update may be provided early next week.

Background

A decision has been made to not introduce the Senedd Cymru (Electoral Candidate Lists) Bill on 4 December, as originally planned.

As a result, technical briefings and other planned stakeholder engagement activities were cancelled on Wednesday 29 November.

As the media technical briefing was due to take place on Thursday 30 November, an invitation had already been issued to journalists and therefore a cancellation notice was sent around 3.30pm on 29 November.

The following line was agreed by Ministers to be used in immediate response to media and stakeholder queries following the news that introduction of the Bill would be postponed.

"We are doing further work on the Senedd Cymru (Electoral Candidate Lists) Bill, which means we will not be publishing on 4 December, as originally anticipated."

Lines to take

Senedd Cymru (Electoral Candidate Lists) Bill

- Further work on the Bill is being undertaken.
- The Special Purpose Committee on Senedd Reform recommended that 'the Senedd should be elected with integrated statutory gender quotas.'
- In June 2022, the Senedd voted in favour by a two thirds majority of endorsing the SPC's report – including its recommendation to introduce legislative gender quotas.

- In July 2022, the Welsh Government formally responded to the Committee's report, stating it would prepare and introduce Senedd Reform legislation to take forward the Committee's recommendations.
- The Co-operation Agreement between the Welsh Government and Plaid Cymru commits the two partners to working together on Senedd reform, including gender quotas.
- We are doing further work on this piece of legislation. We will update Members on next steps in due course.
- We have also kept stakeholders informed of the latest position regarding the Bill and would like to thank everyone who has supported our work on the Bill to date.

If pressed on the leaked version of the Bill:

We do not comment on leaked documents.

Purpose of the legislation

- The Bill is part of our commitment to make the Senedd a more effective legislature for, and on behalf of, the people in Wales.
- Our track record in terms of gender equality in this Senedd is better than many other parliaments could claim, but there is still more we would like to do. Currently 26 (or 43%) of the 60 Senedd Members are women. In 2003 we had a 50/50 split amongst our Members but in recent years that figure has been in decline.
- More women in the Senedd will better reflect the gender make-up of Wales, which is good for politics, good for representation, and good for policy making.
- Several committees and panels over recent years have concluded that gender quotas integrated within the electoral system could make a real difference and in our Co-operation Agreement with Plaid Cymru and in our Programme for Government we set out our vision of seeing gender quotas in law.

- I am not in a position to provide a date for introduction today but will update Members in due course.

Background

[Redacted – Section 35 – Formulation of Government Policy] the Welsh Government put out a statement to the media and relevant stakeholders to say 'we are doing further work on the Bill, which means we will not be publishing on 4 December, as originally anticipated.' In light of this, scheduled meetings and briefings with the media, opposition Senedd Members (Darren Miller – Conservative MS and member of the Senedd Reform Bill Committee) and other interested stakeholders were cancelled.

Following the cancellation of the scheduled media briefing, Welsh Media have published stories online and also reported on radio. A summary of these are provided below:

Media coverage so far:

29 November

BBC and Nation Cymru immediately ran with stories online speculating on reason for delay. BBC also contacted Senedd Commission for comment.

Senedd Commission did not issue a formal comment but said that any advice would be issued with the Bill.

- Synopsis: The Welsh Government has unexpectedly postponed publication of a controversial Bill that would allow biological men to identify as women for the purpose of standing as candidates for the Senedd. The move has led to speculation that serious legal difficulties have become apparent during the drafting of the Bill.
- Lines from WG used.
- Previously published text from leaked draft used and fresh quote from Women's Rights Network who received a leaked draft.

• Synopsis: Plans to create a gender-equal Senedd have been postponed days before they were due to be published. The Welsh government said it was "doing

further work" on a law to make parties nominate the same number of male and female election candidates. There have been questions over whether the Senedd has the power to pass the law.

- Reused comments from Darren Millar last year that 'MSs were told by lawyers they lacked the required powers.'. Later updated to include a new line from Darren Millar which said it had been "abundantly clear from legal advice from previous Senedd committees that the Senedd does not have the competence to introduce this bill. So I hope that this is the beginning of gender quotas being ditched. I have always believed that people should be elected on the basis of merit and not by gender."
- Stated no comment from Senedd until Bill is published.

Social media so far

29 & 30 November

BBC Wales News, Nation Cymru, and Wales Women's Rights Network tweeted about the delay as did Welsh Conservatives following day.

Highest reach for a social media message around the Bill being delayed was circa 15.3m for messages via BBC Wales News (this was also highest reach for a message including Welsh Government on 29 and 30 November). The message was:

Welsh government: Senedd gender quota plan postponed.

Messages with most engagement on this topic also negatively mentioned 'self-ID'. These were two of the top five messages, in terms of engagement, mentioning Welsh Government on 30 November:

 Lets (sic) hope that this isn't just a temporary hitch but the end of @WelshGovernment's attempts to sneak self ID onto the statute books. They know that @SeneddWales does not have the legal competence and that the majority of the public would not support them...2 Replies, 48 Retweets, 135 Likes. This article acknowledges there are questions around whether Welsh Government have the legal authority (they don't). But barely mentions the elephant in the room; They are trying to introduce gender self-ID in Wales by stealth. 27 Replies, 141 Retweets, 510 Likes.

Mid-year review of the Legislative Programme

Year Three Bills introduced

The time critical **Senedd Cymru (Members and Elections) Bill** was introduced on 18 September and the **Elections and Elected Bodies Bill**, which is the next step in our commitment to modernise and reform Welsh elections, was introduced on 3 October. The **Senedd Cymru (Electoral Candidate Lists) Bill**, which will introduce gender quotas for candidates elected to the Welsh Parliament, was due to be introduced on Monday 4 December. In conjunction with Plaid Cymru, a decision was taken to not proceed with introduction and discussions are ongoing regarding next steps.
