- 2. Who is responsible for Clinical Governance in third sector providers commissioned by the APB's in all seven localities.


Our Response

- 1. Welsh Government does not hold specific information on members, their positions within the Area Planning Board (APB) or their respective lines of accountability within each of the 7 APBs. This information would need to be requested from each of the 7 APBs. We are able to provide contact details for each APB at Annex A.
- 2. In relation to responsibility for Clinical Governance each APB is expected, as outlined within the APB Guidance, to have a member who is able to advise on Clinical Governance issues on all services commissioned. Section 8.3 states: "The Local Health Board's clinical representative will have a role in making recommendations in relation to ensuring appropriate clinical governance arrangements have been put in place in respect to services commissioned by the APB".
