Information requested

Thank you for your request which I received on the 11th of June 2024. You asked for:

- 1. The amount of grant awarded to Cwmpas in connection with community-led housing.
- 2. The date any grants in connection with community-led housing were paid to Cwmpas between 2022 and 2024.
- 3. The amount of grant awarded in connection with a project linked to Gŵyr Community Land Trust.
- 4. The name of the recipient awarded grant in connection with a project linked to Gŵyr Community Land Trust.
- 5. The date any grants in connection with a project linked to Gŵyr Community Land Trust were paid between 2022 and 2024.

Our response

The information provided is correct at 30 June 2024.

1. Welsh Government has provided Cwmpas (formerly the Wales Co-operative Centre) with revenue funding to enable them to support co-operative or community-led housing since 2012/13.

The current grant award for Cwmpas's Communities Creating Homes programme is £180,000 for each financial year over the three years 2022/23, 2023/24 and 2024/25. The award totals £540,000 over the three years.

2. Revenue funding for the Communities Creating Homes programme is paid to Cwmpas in quarterly tranches. Cwmpas was paid the following for the programme between 1 April 2022 and 31 March 2024:

3. 4. 5. Welsh Government has awarded up to £892,400 of capital funding to Cwmpas for a project linked to Gŵyr Community Land Trust. The funding was awarded from the Land and Buildings Development Fund. No funding from this grant award has been paid.
