Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 17 July 2024 relating to total knee replacements waiting times. You requested the following:

- 1. What is the length of time in days from referral from a GP to seeing a consultant. Please provide min and max number of days for appointments in the last 12 months*
- 2. What is the length of time from 1st consultant appointment to surgery? Please provide min and max number of days for appointments in the last 12 months*
