ATISN 20807 - Hospitals

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 30 July 2024. You have requested the following:

- *A complete list of NHS hospitals in Wales, and for each hospital, the NHS Trust which is responsible for that hospital. This information was provided in 2013 in spreadsheet format, and I am requesting an updated list in the same format.*

Our Response

The Welsh Government does not hold an updated version of the list that was provided in 2013. However, the information you have requested is already in the public domain. Therefore, it is exempt from disclosure under Section 21 of the Act.

The information relating to NHS hospitals located within local health boards can be found on the NHS Wales website [Contact Us - NHS Wales](#)

It would appear that the information was not in the public domain when it was requested in 2013. Therefore we provided the information in response to that earlier request. Now that the information is publicly available, we are responding to your request by directing you to where the information may be found.

Next Steps

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
