## Information requested

Thank you for your request dated 26 July.

You asked for:

- Clarification that no work has been undertaken on the estimated costs for the additional Senedd Members by the Senedd Commission in preparation for the Senedd Elections.
- Any documents be provided if any work and estimated costs have been provided with notes of any meetings from the Commission Meetings.

In order to produce the costs published in the RIA (a link to which we previously provided to you) the Senedd Commission provided core information relating to the financial implications of the reforms on the Senedd.
