Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o draffordd yr M4, wedi eu bodloni y dylid cyfyngu ar draffig ar ddarn penodedig o'r draffordd oherwydd gwaith y bwriedir ei wneud ar y draffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the M4 motorway, are satisfied that traffic on a specified length of the motorway should be prohibited because of works proposed on or near the motorway.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Traffordd yr M4 (Cyffordd 40 (Tai-bach) i Gyffordd 39 (Y Groes), Castell-nedd Port Talbot) (Gwahardd Cerbydau Dros Dro) 2024 a daw'r Gorchymyn hwn i rym ar 2 Medi 2024.

1. The title of this Order is the M4 Motorway (Junction 40 (Tai-bach) to Junction 39 (Groes), Neath Port Talbot) (Temporary Prohibition of Vehicles) Order 2024 and this Order comes into force on 2 September 2024.

ystyr “cyfnod y gwaith” (“*works period*”) yw’r cyfnod sy’n dechrau am 20:00 o’r gloch ar 2 Medi 2024 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr “y draffordd” (“*the motorway*”) yw traffordd yr M4 Llundain i Dde Cymru.

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd ar y darn o’r llain galed sy’n gyfagos i gerbyttffordd tua’r dwyrain y draffordd a lôn gyntaf cerbyttffordd tua’r dwyrain y draffordd sy’n ymestyn o drwyniad y ffordd ymuno tua’r dwyrain wrth Gyffordd 40 (Tai-bach) hyd at yr arwydd gantri i’r gorllewin o Gyffordd 39 (Y Groes), Castell-nedd Port Talbot.

“the motorway” (“*y draffordd*”) means the M4 London to South Wales motorway;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 20:00 hours on 2 September 2024 and ending when the temporary traffic signs are permanently removed.

Prohibition

3. No person may, during the works period, drive any vehicle on the length of the hard shoulder adjacent to the eastbound carriageway of the motorway and lane 1 of the eastbound carriageway of the motorway that extends from the nosing of the eastbound entry slip road at Junction 40 (Tai-bach) to the gantry sign to the west of Junction 39 (Groes), Neath Port Talbot.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration for this Order is 18 months.
