Request for Information – ATISN 20790

Thank you for your request, which I received on 3 September.

The Freedom of Information Act only provides a right to ask for copies of recorded information already held by a public organisation.

In this context you have asked for the following information:

- a) The climate change evidence "net zero" projects are based on, to justify large scale industrial onshore wind and solar farms in the Welsh countryside for Future Wales 2040 targets?
- b) Evidence used to ensure your property, in close proximity to the proposed projects, will not depreciate in value.

Your requests numbered 2, 3 and 5 in your letter do not ask for recorded information already held and would require information to be generated and therefore do not comprise valid Freedom of Information requests. You will receive a response to these matters separately.

Our Response

- a) This information is already in the public domain and is summarised in pages 45-46 of Future Wales, which can be accessed on the Welsh Government's website at https://www.gov.wales/future-wales-02/future-wales-the-national-plan-2040.pdf. - b) We do not hold this information.

The request you sent me contains personal information about you - for example, your name. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response. We will only use this personal information to deal with your request and any matters which arise as a result of it.
