We were due to be considering the application at planning Committee today, but took the

decision yesterday to defer following a site ecology response which we were advised was coming. It can be found here: [Microsoft Outlook - Memo Style \(agileapplications.co.uk\)](https://agileapplications.co.uk/Microsoft_Outlook_-_Memo_Style)

The committee report can be found here, [NP-0198-FUL-Moylegrove.pdf \(pembrokeshirecoast.wales\)](https://pembrokeshirecoast.wales/np-0198-ful-moylegrove.pdf) but a revised report will be prepared for the September Committee.

There is an added level of complexity to the application and its potential effects on the nearby SAC – although the application site is over a mile from the beach at Ceibwr where the co-steering activities take place, whether this will intensify the impacts on the SAC is something we are still assessing. We're also awaiting the outcome of an NRW study which has already been commissioned looking at the impact of co-steering on nesting wildlife.

The building being considered has been supported (subject for grant funding by Pembrokeshire County Council with Levelling Up funding, and there appears to be a level of conflicting information between the grant application forms and the planning statements which requires resolving.
