Thank you for your request for information dated 22 August 2024.

Information requested

You asked for the following information:

- 1. Total cost of the introduction of 20mph legislation in Wales including the installation of signage, advertising, information to communities
- 2. Total cost of the Consultation process initiated by yourself as part of the consideration of revoking or changing 20mph zones and/or Legislation to date

Our response

I can confirm that the Welsh Government holds some of the information you have requested.

The total cost of the 20mph scheme up to 31 August 2024 is £38,274,953. This includes:

1. Financial assistance to local authorities: £35,584,969.80

2. Consultancy: £1,391,445.81

3. Research: £233,469.82

4. Marketing: £1,065,067.50

The 22 highway authorities in Wales are responsible for replacing signage on their roads. The Welsh Government provided funding to carry out this work but does not hold detailed information about the quantities of signage removed or changed, signage stored or signage scrapped.

Personal Information

The request you sent me contains personal information about you - for example, your name and email address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.
