I wrote to you on 5 September regarding your request for information.

Your request

1. When funding is received by Business Wales from the Welsh Government what percentage of the fund is spent directly on your costs, for example Wages, Working From Home cost savings.

We will deem the above as a request for funding provided to Business in Focus to deliver the Business Wales Business Development and Growth contract on behalf of the Welsh Government.

2. How much have you actually provided by way of grant funding to Welsh SMEs

We will deem the above as a request for grant funding delivered by Business in Focus on behalf of the Welsh Government.

- 3. How many staff does business Wales employ to include contracted and directly employed
- 4. The CEO's final salary
- 5. What percentage of income is directly awarded to Welsh Business compared to the above costs.

Our Response

I can confirm that the Welsh Government holds most of the information you have requested.

For question one, we do not hold this information.

For question two, for the 2024/25 financial year, £4,037,000 is the total budget provided to Business in Focus to deliver the Business Wales Business Development and Growth contract on behalf of the Welsh Government. This equates to circa 60% on staff costs. We don't hold any data on working from home cost savings.

For question three, the Business Wales service is delivered via five key strands which includes an internal Digital and Helpline team and a team to manage the whole service, one grant to deliver the Social Business Wales service and three direct contracts this includes the Business Development and Growth service (BDG), Entrepreneurship & Start-up service (ESU) and the Accelerated Growth Programme (AGP).

In total, the Business Wales service employs 160.2 full time equivalent (FTE) contracted staff and 33 part-time (PT) contracted staff. The Welsh Government directly employs 36 FTE internal staff to deliver the Business Wales service.

For question four, I can confirm that Business Wales does not have a CEO.

For your final question, Business in Focus on behalf of the Welsh Government delivered the Barriers to Start Grant at a cost of £3,539.554.70 (this fund is now closed). Business in Focus on behalf of the Welsh Government is currently delivering the Young Persons Start Up Grant and at a cost to date of £986,249.47.
