Engaging with [information redacted] via interviews would extend beyond our project's initial scope and strain our resources. However, recognizing the importance of including high-influence stakeholders like the [information redacted], we proposed accepting written responses.

This approach ensures that the project remains within its defined objectives and budget, while still giving these groups a voice. Written submissions allow for objective data collection, aligned with the research's goals, and can be more easily analyzed and compared. They also provide a safe platform for [information redacted] to share their perspectives on a sensitive topic. In essence, this method balances the need for comprehensive insights from special interest stakeholders with the project's constraints, ensuring effective stakeholder engagement and maintaining the project's integrity.

We would be willing to engage with a wider scope, but our ability to absorb costs has been taken up with the increased time needed to complete the risk audit and action plan kicked off by [information redacted], so if there is a strong need to do this, we would need to revisit the budget.
