

## DEDDF CYNLLUNIO GWLAD A THREF 1990

### GORCHYMYN CAU PRIFFYRDD (CRAWFORD STREET, CASNEWYDD) 2024

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 ("Deddf 1990") i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. Mae Gweinidogion Cymru wedi eu bodloni bod angen cau'r briffordd. ## TOWN AND COUNTRY PLANNING ACT 1990

### THE STOPPING UP OF HIGHWAYS (CRAWFORD STREET, NEWPORT) ORDER 2024

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The Welsh Ministers are satisfied that the stopping up is necessary, and it will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by Newport City Council on 3 July 2024 with reference 22/1033 and described in Schedule 2 to this Notice.

The Stopping Up of Highways (Crawford Street, Newport) Order 2024 ("the Order") ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge during normal office hours at Newport Central Library, Kingsway Centre, 4 John Frost Square, Newport NP20 1PA, or may be obtained free of charge from the address below quoting reference qA2221701.

If a person is aggrieved by the Order, on the grounds that:

- it is not within the powers of the 1990 Act; or
- a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 5 December 2024 make an application for the purpose to the High Court.

**Length of highway to be stopped up**

A rectangular shaped length of the footpath adjacent to the property at number 22 Crawford Street, Newport, NP19 7AY, with a maximum length of 32 metres and a maximum width of 2.5 metres and marked with zebra hatching on the deposited plan.

**The Development**

Demolition of existing building and construction of 30 apartments along with associated parking and external areas at Gwent Car Sales, Crawford Street, Newport NP19 7AY.
