

**GORCHYMYN CEFNFFORDD YR A470  
(BLAENAU FFESTINIOG, GWYNEDD)  
(GWAHARDD CERBYDAU DROS DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A470, neu gerllaw iddi, ym Mlaenau Ffestiniog, Gwynedd.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd rhag mynd ar y darn o'r gefnffordd sy'n ymestyn o ochr orllewinol y marciau cyffordd wrth ei chyffordd â Heol Bowydd hyd at ei chyffordd ag ochr ddwyreiniol Cylchfan Commercial Square.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r de o Commercial Square yw mynd ar yr A496 tua'r de hyd at ei chyffordd â'r A487 i'r gogledd o Faentwrog a'r A487 tua'r de-ddwyrain hyd at ei chyffordd â'r A470, i'r dwyrain o Gellilydan i ailymuno â'r A470 tua'r gogledd/de: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gogledd o bwynt deheuol y darn o'r ffordd sydd ar gau.

Daw'r Gorchymyn i rym ar 6 Ionawr 2025. Disgwylir y bydd y gwaharddiad dros dro yn weithredol dros nos (21:00 – 07:00 o'r gloch) rhwng 6 ac 11 Ionawr 2025, neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A470 TRUNK ROAD BLAENAU  
FFESTINIOG, GWYNEDD) (TEMPORARY  
PROHIBITION OF VEHICLES) ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A470 trunk road at Blaenau Ffestiniog, Gwynedd.

The effect of the Order is to temporarily prohibit all vehicles from proceeding on the length of the trunk road that extends from the western edge of the junction markings at its junction with Bowydd Street to its junction with the eastern side of Commercial Square Roundabout.

The alternative route for southbound vehicles from Commercial Square is via the southbound A496 to its junction with the A487 north of Maentwrog and the south-eastbound A487 to its junction with the A470, east of Gellilydan to rejoin the north/southbound A470: vice versa for northbound vehicles from the southern point of the closure.

The Order comes into force on 6 January 2025. The temporary prohibition is expected to operate overnight (21:00 – 07:00 hours) from 6 – 11 January 2025, or until the temporary traffic signs are permanently removed.

Although the Order is only expected to be in force during the period specified above, it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Notice of any changes to times and dates will be displayed before any rescheduled work begins.
